# **3.2.4 QUESTIONS WITHOUT NOTICE FROM THE PUBLIC**

### Douglas Janney – 23 Watkinson Street, Devonport

Q1. The Council has a road legacy with the depressions from the manholes and hand holes. This has been due to the Council's personnel not adequately supervising the words. The latest instance is the 2 depressions at the roundabout at Fenton and Stewart Streets about which nothing was done.

When is the Council going to fix all these depressions?

### Response

The Mayor advised that the question would be taken on notice.

### Rodney Russell – 225 Steele Street, Devonport

**Q1.** Next Annual General Meeting, could councilors be facing the gallery so that the gallery and for live streaming, can see who they are and how they vote. Also, the Mayor's table had water but councillors did not and bottled water could have been provided for those who may have required it

### Response

The Mayor advised she would take that as comment.

**Q2.** Holyman Street reconstruction, can you tell me who made the decision to have a footpath placed with the power poles in the middle, Devonport City Council or the contractor?

### Response

The General Manager advised that Council did the design.

Q3. Would Devonport City Council consider not selling the piece of land beside the old library, instead, keep it until the old library has been demolished, then reinstate Fenton Way back to a straight through two-way traffic, which would give better access to the multi-level car park?

## Response

The Mayor advised that nothing has been decided so all of those things are still under advisement.

## Christopher Mills – 52 Caroline Street, East Devonport

**Q1.** A1 Tree Services are Council's preferred contractors. A1 Tree Services promote themselves as "our team of highly qualified arborists assess your trees and generate reports identifying issues, illness and symptoms". So far this administration has declined to clarify if there is a qualified arborist on the staff. There is a service agreement between A1 Tree Services and Devonport Council for assessing trees, thinning them, cutting them down and removing them. This service agreement is renewed yearly. Is A1 Tree Services with their team of "highly qualified arborists" the reason why there is no qualified arborist on this administration's staff?

## Response

The Mayor advised that the question would be taken on notice.

**Q2.** I notice the discussion about approving the answers given to questions, so this concerns the identical answers given in the Agenda to my two questions on notice of the 16 November. If I may remind everybody of these answers, "Council has previously answered many questions in response to the removal of trees at 54 Caroline Street and cannot add anything further" (this agenda page 9). It is clear from letters in my possession from two previous administrations, that these trees were stabilizing a landslip hazard zone next to my home and should not be removed. Despite being fully aware of the evidence this administration cut the trees down on 5 November 2019. As a foreseeable consequence of that action my house is now at risk of structural damage. Of course, it is not the homes of the current General Manager, the executive staff, the Mayor or the councillors that have been put at risk by the actions of this administration, it is my home at risk. Would it not be more appropriate for this administration to answer my concerns about my property and answer any questions fully and transparently, beginning with providing full and transparent answers to my two questions "on notice"?

## Response

The Mayor said she does believe his questions have been answered in the past, but we will respond in writing.

## Bob Vellacott – 11 Cocker Place, Devonport

**Q1.** At the Annual General Meeting, Deputy Mayor Councillor Jarman declared an interest, in regard to Mr Nevin's notice of motion requesting an independent inquiry about Providore Place, then left the room and refrained from voting. Would the Mayor explain, why you and others in Council who were responsible for the shemozzle pertaining to Providore Place did not follow the Deputy Mayor's good example?

### Response

The Mayor cautioned Mr Vellacott in regard to offensive remarks and asked he show more respect when addressing Council.

The Mayor advised that each councillor makes their own decisions around conflicts of interest.

Q2. The unconfirmed minutes of the 2020 Annual General meeting included that Cr Sally Milbourne raised on three occasions a point of order while Mr Gardam was

questioning the Mayor as to who in the gallery at the 2019 Annual General Meeting was getting a bit out of control. However, the General Manager omitted to record other points of order raised by electors and I wonder why? I refer to and note that – Renton's "Guide for Meetings and Organisations states on page 112 at item 7.7 "Points of order taken and the rulings on them should be included in the minutes", I stress the words "should be included". Would the General Manager give good reason why he did not include in the minutes that Mr Malcolm Gardam raised a point of order against Mr Greg Marshall because he was not speaking to the notice of motion that requested an apology from Council for their mismanagement of Providore Place? And, would the fact that Mr Graeme Nevin also raised a point of order against Councillor Leigh Murphy whilst he was speaking against Mr Nevin's notice of motion requesting Council to support having an independent inquiry about Providore Place?

### Response

The Mayor advised that minutes of the Annual General Meeting that were held earlier this month will be endorsed at next year's Annual General Meeting and amended if they need to be at that point.

### Jennie Claire – Ratepayer, Devonport

Q1. I wish to correct a mistake that I made at the recent AGM. During my question regarding the handling of the motions which were passed at the 2019 AGM, I misquoted the minutes of the December 2019 meeting. I said the four motions had already been considered, and I said that was a direct quote, and that was wrong. I should have said, "Council having considered the motions". So I apologise that my quote was not quite right, as the General Manager pointed out, but I would say that the two sentences actually mean the same thing. Both convey the idea that the motions had been considered past tense. At that meeting, Councillor Jarman stated that on her reading of the Local Government Act, a motion passed at the AGM must be considered at the next meeting of Council. Indeed, at the 2019 AGM, the Mayor stated that "motions that are carried at the AGM are brought to the next Council meeting", and that's a direct quote. So from what was said by the Mayor and Councillor Jarman, we would be justified in thinking that these motions would be considered at the next meeting, yet they weren't. At the relevant item, namely 5.2 the resolution states, and this is a quote, "That Council note the minutes from Council's 2019 AGM, and having considered the four motions from the meeting", and so on. That was all that was said regarding two of the motions. Does that qualify as brining the carried motions to the next Council meeting? Does that qualify as considering the motions? I don't believe so and I don't believe any reasonable person would think that it does. The relevant resolution in the December 2019 minutes contains only six lines. The Mover, Councillor Hollister, and the Seconder, Councillor Enniss, had nothing further to add. Councillor Jarman raised discussion about the format of the report, but no amendment was put so it remained unchanged. So that was the extend of the consideration given to the motions which concerned ratepayers had spent hours researching and writing. Mr Atkins stated at this year's AGM that that report is there for anyone to see. Yes, all six lines of it, with no mention of what two of the motions were. There is not much there for everyone to see. So yet at our recent AGM, Mr Atkins stated that he's comfortable that the correct process was followed. He further stated, "I'm confident that the report may the requirements of the Local Government Act, and provided those motions for Council's consideration". Seriously, two of the motions were not even mentioned. On that basis, it would be absolutely fine tonight, if Mr Janney's motion which passed at the recent AGM, was not mentioned. It could have already been considered and eliminated with the report and Mr Atkins would be comfortable with that and further to me it's disappointing that only one of our councillors, Councillor Jarman, took issue with the report at the last year's AGM, and none of the councillors felt the need to make an amendment to bring it in to line with the Act. So my question tonight is, to you Mayor, to Mr Atkins, to all the councillors, if for example tonight, Mr Janney's motion about the parking for ratepayers of 50 years, wasn't even listed in the report, would you be comfortable with that, and if you wouldn't be comfortable with that, why was everyone comfortable that my motion and another motion last year were just eliminated from the report, not even mentioned what the motions were.

#### Response

The Mayor advised that everything that is on the Agenda will be discussed tonight, and what happened last year is not directly relevant to what is happening this year, given that we as Council have discussed the Agenda from last year and the minutes were passed at the most recent AGM.

The General Manager noted that the report referred to was twelve months ago and that there were some paragraphs around each of the motions in the report, so it is incorrect to say that the report did not consider the motions to which Ms Claire refers. There was certainly commentary around those motions in that report.

Ms Claire asked for that information to be quoted. The General Manager suggested that Ms Claire may be getting mixed up with the recommendation and the body of the report. There was a report that went with the recommendation, and in the body of the report there would have been commentary about those motions and the fact that councillors didn't discuss it in detail is not to say that they haven't considered it. Like a lot of items, they read the report and give consideration and make comment as necessary.

Ms Claire said so what you're saying is the extra information was in an attachment? The Mayor confirmed it was in the body of the report. Ms Claire disputed that the information was there and the Mayor advised that a link to the agenda of that meeting would be forwarded to her.
