3.2.3 QUESTIONS WITHOUT NOTICE FROM THE PUBLIC

Rodney Russell 225 Steele Street, Devonport

Q1. After seeing so many shopping trolleys in front of the Devonport Regional Gallery, I approached the front staff of the Gallery at the Gallery who said they were in good contact with the supermarkets for their removal. My question is, is there anything more that Devonport City Council can do to prevent these trolleys from making their way so far from the supermarket?

Response The General Manager confirmed that Council are in regular contact with the supermarkets when abandoned trolleys are in the area.

The Mayor further advised that there is an online system that members of the public can also use to report to the supermarkets and that there is a link on our website.

Q2. In tonight's Agenda under Infrastructure and Works Report, I see Council's about to restain the external timber cladding to the Devonport Surf Club.

Previously you have replaced three roller doors because of rusting. Question, do you have any plans in place to replace or repair the colorbond cladding damaged due to stones or kicking by unknown persons - that is the cladding that comes down the side?

Response The General Manager advised that there are no plans to do so at the moment.

Q3. At the last Council meeting, I asked if Council could remove the residue tape which had held the planning notice to the multi-story car park. The General Manager's response in writing was that he regarded the question as comment and would action only if considered necessary. Well, I took the Mayor's advice from the last meeting, and tried to remove it this afternoon. It won't come off. So, my question is, I think I have to leave it to the General Manager to take care of it.

Response The Mayor thanked Mr Russell for trying to remove the residue.

Trevor Smith, 7 Glen Court Devonport

- Q1. The zebra pedestrian crossings at the Splash Aquatic Centre have faded to a poor condition. When will you be getting these pedestrian crossings painted to an acceptable standard?
- **Q2.** How much money has been raised so far since you started selling off surplus assets to pay down the debt of the LIVING CITY?
- Q3. The Council has been in the paranaple centre for at least three to four years now. Why is there a loose plastic hang of the windows on the western side of this building?

Response The General Manager responded to **Q3**, advising that the windows at the western end of the building have got some cracks in them, resulting from vandalism, and that the plastic has been placed over the cracks until such time as the replacement glass arrives.

The General Manager further responded to **Q2** by advising that Council is not selling any assets to pay debt on LIVING CITY, and that **Q1** will be taken on notice.

Douglas Janney, 23 Watkinson Street Devonport

Q1. Tonight's Agenda items have authors and endorsers. The Index on page 2 and 3 is not correct, as the page numbers and the item numbers do not agree with the item numbers from 5.2 onwards. In August last year the same problem occurred with the item numbers and page numbers being mismatched.

Is the index checked before the agenda is published?

Response The Mayor responded by advising that it is. The General Manager further confirmed that the agenda is checked, and that it is collated automatically, but the question will be taken on notice in regard to the numbering, and a response will be provided.

- **Q2.** Agenda Item 5.1 shows a carryover of 50% of the capital works for the 2021 year. This suggests when the budget was prepared that the capital works amount was:
 - 1. over optimistic;
 - 2. there was not enough personnel to undertake the work; or
 - 3. the Council personnel were not working hard enough.

Which of these three possibilities applies?

Response The General Manager responded by adding a fourth point, that there's been a significant amount of government funding that came in through the year that was added to the program, and resulted into some projects originally intended to be constructed during the year being deferred or carried over, and an additional point that a number of the larger projects extend across multiple financial years such as the

LIVING CITY Waterfront Park, and that the full amount was budgeted in the year with the intention that part would be carried forward.

Bob Vellacott, 11 Cocker Place Devonport

Q1. Due to some confusion that arose at the 2020 Annual General Meeting during question time, because general comments were also being made and or accepted, therefore I respectfully ask the Mayor will you ensure that questions from the floor and comments are listed as separate items in the Agenda and treated as such for the 2021 Annual General Meeting?

Response The Mayor thanked Mr Vellacott for his submission and that it will be taken under advisement.

Q2. Mayor - I refer to the minutes of the meeting of the 27th of September 2021 – re-proposed name change for Providore Place. The following declarations of interest were advised:

The Mayor, your reason was "related to a decision of a previous Council".

Councillor Laycock's "on the Council when Providore Place was voted on".

The Mayor interjected by advising that Council had received a similar question from Mr Vellacott in writing, and that it was decided not to accept it, as it did not meet Council's policy and that she was not prepared to accept it again tonight.

Mr Vellacott continued that he did not recall the Mayor or any other Councillor in recent times declaring an interest when seemingly more relevant items about sorting out the problems pertaining to Providore Place have been on the agenda and he wondered why this occurred on September 27th?

Based on your reasons for declaring an interest, because Councillor Murphy's Notice of Motion related to a decision of a previous Council, does that mean that if he should in the future give a Notice of Motion to change the name of Market Square to Martin Place, would you also be obliged to declare an interest for that?

Q 3. I refer to my previous questions commencing 25th of January 2022 about the total legal cost so far for legal advice given to Council pertaining to Providore Place. Only a percentage of the cost has been able to be given, because I quote "legal costs are not captured or reported to the detail you request".

Now, I wish to inform I received very reliable information that as at the 28th of January 2022 the legal costs charge to Council for Providore Place development.

Councillor Perry raised a point of order, highlighting that Mr Vellacott had twice incorrectly referred to the date as 2022.

Mr Vellacott continued to inform that he had received very reliable information that at the 28th of January 2020, the legal costs charged to

Council for Providore Place amounted to a total of \$21,669 and he noted that it was not an approximate percentage figure given, but an actual amount.

Given that Council officers were able to capture accurately legal costs for Providore Place, up to the 28th of January 2020, why is it that since that time costs are not captured at the same level so they can be made available for the edification of ratepayers?

Response The Mayor advised that the question had been asked and responded to several times and that the question would not be accepted.
