PROJECT NAME: Maidstone Park – safety netting

**PROPOSED STATUS:** Construction in 2022-23

**PREVIOUS STATUS:** Not previously listed

**PROPOSED BUDGET:** \$49,000

**PROJECT OBJECTIVE:**Prevent balls from being retrieved from the road

during games

Project justification: During games on Maidstone Park ground number 1, balls can be kicked through the northern goals and onto Bay Drive. The balls often retrieved from the road by children, who are then at risk of being hit by traffic on Bay Drive.

Council has secured \$25,587 from the Improving the Playing Field program for this project. Council is required to contribute the remainder of the estimated costs (\$23,413).

Project scope: Installation of netting behind the northern goals of ground number 1.



Project name: Mersey Vale Memorial Park – Lawn Cemetery –

modern burial system - stage 3

**Proposed status:** Construction in 2022-23

**Previous status:** No change

**Proposed budget:** \$1.10 million

**Project objective:** Provide additional capacity for burials

**Project justification:** This project ensures demand for traditional burials can be met in the lawn cemetery.

As part of the implementation of Council's Cemetery Strategy 2011-2030, a staged construction of concrete burial chambers allows maximum utilisation of otherwise unusable parts of the Lawn Cemetery.

**Project scope:** Installation of an additional 300 plots, which is three years' supply (reduced by reservations



Project name: Installation of public recycling bins

**Proposed status:** Construction in 2022-23

**Previous status:** No Change

Proposed budget: \$35,000

**Project objective:** Waste Diversion

**Project justification:** Council installed 17 public recycling bins in 2021. An increased number would provide more opportunity more waste diversion, provide a more consistent service, and improve the scale of the collection activity.

Public place recycling is an expectation for many locals and visitors and is an outward display of Council's Vision "Devonport will be a thriving and welcoming regional city living lightly by river and sea."

**Project scope:** Install 15 new recycling bins paired with existing waste bins.





Project name: Spreyton Netball Centre – surface renewal – 2 courts

**Proposed status:** Construction in 2022-23

**Previous status:** No change

Proposed budget: \$30,000

**Project objective:** Asset renewal

**Project justification:** The surface on two courts on the western side of the centre requires renewal. Two courts were renewed in 2020-21 and two more courts are now in the same condition.

**Project scope:** Resurface two courts.



Project name: East Devonport park furniture

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

Proposed budget: \$20,000

**Project objective:** Meet community expectations

**Project justification:** Council has received correspondence in recent months identifying locations on the East Devonport foreshore that lack park furniture. It is proposed that 4-5 additional pieces of furniture would meet the needs of frequent park users, including those who have made the requests.

**Project scope:** 4-5 new seats, benches, or tables on the East Devonport foreshore, between Melrose Street and Tea Tree Lane.



Project name: Park furniture renewal - annual program

**Proposed status:** Construction in 2021-22

**Previous status:** No Change

Proposed budget: \$25,000

**Project objective:** Asset Renewal

**Project justification:** Many older items of timber park furniture require renewal as they approach end of life. Some current furniture is also difficult to use for people with limited mobility.

**Project scope:** Continue with replacement of park furniture that is at end of life. Candidate locations include:

- Bluff road Between North Fenton Street and Skate Park.
- Coles Beach.



Project name: Byard Park Lighting

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

**Proposed budget:** \$314,000 (\$263,004 external)

**Project objective:** Increase opportunity for participation

**Project justification:** The provision of lighting to Byard Park increases opportunities for winter sports training and games, where opportunities can at times be restricted by daylight hours or the condition or access to the nearby Devonport Oval. This may result in

Council has secured \$263,004 from the State Government's Improving the Playing Field grant program and is required to contribution the remaining \$50,996.

Before progressing to construction, there are some remaining issues to resolve including:

- Stakeholder consultation, particularly with adjacent residents
- Successful progression through the Development Application process

However, should these issues be resolved, a Council budget allocation is required to deliver the project.

Project scope: Installation of four light towers (100-140 lux) that can be operated remotely using a smart switch.





Project name: Park BBQ renewal

**Proposed status:** Construction in 2022-23

**Previous status:** No change

Proposed budget: \$20,000

**Project objective:** Asset Renewal

**Project justification:** BBQs provide an opportunity for community gatherings in Devonport's parks are hold an important place in Australian culture.

Park BBQ's can last around 15 years but towards the end of life, they can become slow to heat and can't maintain heat. Renewing three park BBQs ensures the BBQ facilities are fit for purpose and continue to deliver benefits to the community.

**Project scope:** Replace three park BBQs. Current BBQs at the Vietnam Veterans Memorial Park (Aikenhead Point) are identified as a priority.



Project name: Don Reserve path upgrade – Don River

**Proposed status:** Construction in 2021-22

**Previous status:** Not previously listed

Proposed budget: \$35,000

**Project objective:** Asset renewal

**Project justification:** The existing gravel section of path under the rail bridge is narrow and curved and could be improved for the increased number of bike riders expected on this section now the Don River Bridge is open. The section to the north is wider and straighter so a gravel surface is suitable in the short term for this section.

**Project scope:** Prepare and seal 80m of path adjacent to the Don River. Barriers or handrails installed to relevant standards as required.





Project name: Waste Transfer Station – foreshore rehabilitation

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

Proposed budget: \$50,000

**Project objective:** Environmental management

**Project justification:** The northwest corner of the Spreyton Waste Transfer Station has until early 2022 been unfenced and the ground largely consists of waste material. This results in a high potential for in ground and on ground waste material (mostly plastics) entering the Mersey River. The installation of the fence will intercept airborne rubbish, so an opportunity exists to rehabilitate the site to prevent in ground rubbish from entering the river, while preparing the site for the proposed Spreyton Quoiba path link.

**Project scope:** Initial clean up, minor earthworks (to facilitate future Spreyton-Quoiba path link), geofabric and soil capping, native vegetation and grasses.





Project name: Kelcey Tier – map signage

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

Proposed budget: \$15,000

**Project objective:** Improved user experience, Risk management

**Project justification:** There is limited signage available for users of the Kelcey Tier greenbelt. Users may be unsure of routes and journey times and could even become lost in the 185Ha reserve.

It is proposed to install map signage at the entry points, that is consistent with the existing signage family and supports any existing route naming/numbering

**Project scope:** Install new map signage.



Project name: Kelcey Tier - fire trail renewal and consolidation

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

Proposed budget: \$50,000

**Project objective:** Risk Management

**Project justification:** The network of fire trails in Kelcey Tier is vital for emergency access.

In conjunction with TFS, it is proposed to assess the access needs for firefighting and ensure that the network is fit for purpose. If redundant trails are identified, these can be downgraded to walking trails or closed and rehabilitated.

**Project scope:** Renewal of priority fire trails, including closure or downgrade of redundant trails.



Project name: Rooke Street Mall furniture renewal

**Proposed status:** Construction in 2022-23

**Previous status:** No change

Proposed budget: \$200,000

**Project objective:** Asset renewal

**Project justification:** Three elements of furniture in the Rooke Street Mall required renewal:

#### Seating:

The existing seating was installed in 2005 and although structurally sound, is aesthetically out-of-date, has poor ergonomics and will require repainting in the next two years if not replaced. It appears that there is more seating than is currently required. It is proposed to rationalise seating and renew with a range of furniture compatible with current and future use of the area

#### Planter boxes:

the planter boxes are the same light green colour as the seating, but several have severe rust and are aesthetically unpleasant

#### Shade sails:

Shade sails were removed in 2019 to allow the poles to be repainted and were not fit for re-use



Project name: Don Reserve path renewal - Jiloa Way to Don Railway

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

Proposed budget: \$100,000

**Project objective:** Asset Renewal

**Project justification:** Continued renewal and enhancement of the highly utilised of Don Reserve Path network. The loop path from Don Reserve to the Aquatic centre carpark requires sections to be replaced over the next four years.

The length of path from Jiloa Way to Don Railway has been assessed as requiring works due to cracking, edge breaks and depressions.

Project scope: Reconstruct hot mix path between Jiloa Way and Don Railway.





Project name: Aquatic Centre - waterslide entry structure renewal

**Proposed status:** Construct in 2022-23

**Previous status:** No change

Proposed budget: \$55,000

**Project objective:** Asset renewal

**Project justification:** The timber structure providing access to the top of the waterslide needs renewal.

**Project scope:** A replacement of similar design is proposed.



Project name: Highfield Park Skate Park

**Proposed status:** Construction in 2022-23

**Previous status:** Not listed

**Proposed budget:** \$90,000 (includes \$60,000 external funding)

**Project objective:** Master Plan action

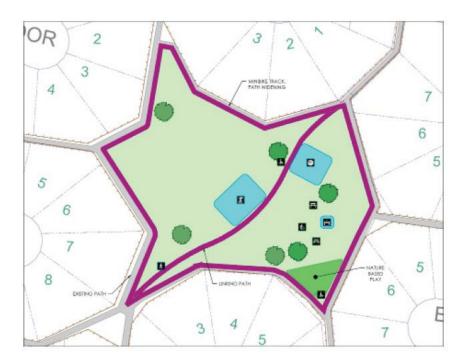
**Project justification:** Construction of a new skate park at Highfield Park is an action in the Highfield Park Master Plan 2018-28. The project requires external funding to proceed. A submission has been made to the Premier's Fund for Children and Young People for \$60,000 and Council are awaiting the outcome, with the balance to be funded by Council. Devonport Community House have also offered support to the project.

A skate park would provide local recreational opportunities for a community facing a number of challenges.

Note that if the grant application is unsuccessful, the project cannot proceed

**Project scope:** Design and construct a new skate park in collaboration with Devonport Community House and key users.





Project name: Local Roads and Community Infrastructure Program –

Phase 3

**Proposed status:** Construction in 2022-23

**Previous status:** Not previously listed

**Proposed budget:** \$314,466 (external funding)

Project objective:

Deliver projects that align with relevant Council

strategies and meet funding criteria

**Project justification:** Council has received funding under three phases of the federal Government's Local Roads and Community Infrastructure Program. To date, \$314,466 remains unallocated from Phase 3.

If eligible, projects already listed in the 2022-23 capital works program can be nominated. It is anticipated that the allocation will be used for a combination of projects already included in the program and others that will be brought in.

**Project scope:** Nominate and deliver agree projects up to \$314,466 prior to 30 June 2023.

Project name: Street Light Provision 2022-23

**Proposed status:** Construction in 2020-21 (annual provision)

Proposed budget: \$15,000

**Proposed objective:** Asset renewal

**Project justification:** This allocation is required for replacement of pole assets and to provide new street lighting poles where a need is demonstrated.

**Project scope:** Works is identified throughout the year from asset inspections and public requests.



Project name: Footpath missing links - high priority areas

**Proposed status:** Construction in 2022-23

Proposed budget: \$100,000

**Proposed objective:** Asset renewal

**Project justification:** The accessibility of the footpath network can be impacted by sort missing sections of path, or by missing or non-complaint ramps.

**Project scope:** Construction of footpath and kerb access ramps, prioritised by walkability and value for money.



Project name: Reseal Program 2022-23

**Proposed status:** Construction in 2022-23 (and annually)

Proposed budget: \$660,000

**Proposed objective:** Asset renewal

**Project justification:** Road wearing-seal assets require replacement at end of life to continue to provide a safe and smooth ride, and to protect underlying pavements from damage.

**Project scope:** Roads are identified by condition inspections which occur throughout the year. Asset planning has identified that an allocation of approximately \$660,000 is required to renew assets that will reach end of life in 2022-23.

This program includes an associated operational budget allowance to undertake preparation work prior to the new seal being applied.



Project name: State Vehicle Entry Point Project – Allocation 3

**Proposed status:** Construction in 2022-23

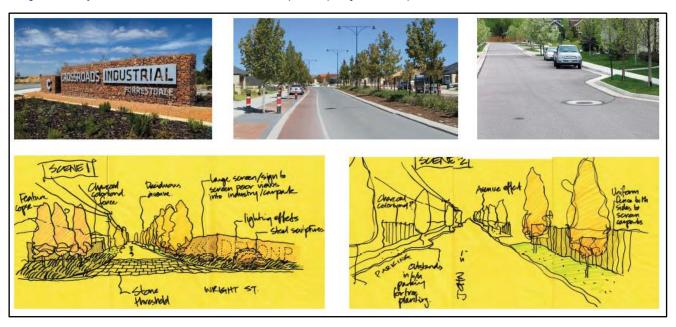
Proposed budget: \$500,000

**Proposed objective:** Asset renewal

**Project justification:** This project represents the commencement of works associated with the Spirit of Tasmanian arrival point in East Devonport. The project is proposed to be fully grant funded, with other works being delivered in partnership with TasPorts.

Total project budget is \$3 million, with expenditure likely to occur over the next two financial years.

**Project scope**: In accordance with adopted project scope.



William Street renewal - Valley to Middle additional Project name:

Construction in 2022-23 **Proposed status:** 

Proposed budget: \$605,000

Proposed objective: Asset renewal

**Project justification:** Council consider tenders for the renewal of William Street between Valley Road and Middle Road in January 2022 and committed \$605,000 in 2022-23 to enable the project to progress (Min 22/10 refers).

**Project scope:** The project renews an arterial Road and includes some safety improvements at the Middle Road roundabout.

(1) New road pavement & surfacing - Renewal and Strengthening of road (4) New traffic Islands, wider paths - For safe and improved pedestrian access.

2 New kerb & channel and driveways- To suit pavement changes

(5) New kerb access ramps - To meet new standards.

(3) New larger roundabout - For safer traffic movement.



Project name: Road traffic device renewal

**Proposed status:** Construction in 2022-23

Proposed budget: \$15,000

**Proposed objective:** Asset renewal

**Project justification:** This allocation is required to renew damaged or non-compliant road traffic devices, such as safety barrier, pedestrian fences traffic islands and bollards.

**Project scope:** Renewal of traffic devices as identified during the year.

PROJECT NAME: Parking infrastructure renewal

PROPOSED STATUS: Construction in 2022-23

PREVIOUS STATUS: No change

PROPOSED BUDGET: \$25,000

PROJECT OBJECTIVE: Asset renewal

Project justification: This allocation is required to address parking meter renewal items that are identified throughout the year.

Project scope: Work is identified throughout the year via asset inceptions.

Project name: Transport Minor Works Program

**Proposed status:** Construction in 2022-23 (and annually)

Proposed budget: \$25,000

**Proposed objective:** Asset renewal

**Project justification:** This budget item represents an annual allocation to address low-cost items that are identified throughout the year.

**Project scope:** Work is identified throughout the year via asset inspections and customer requests.

Project name: William and George Intersection renewal

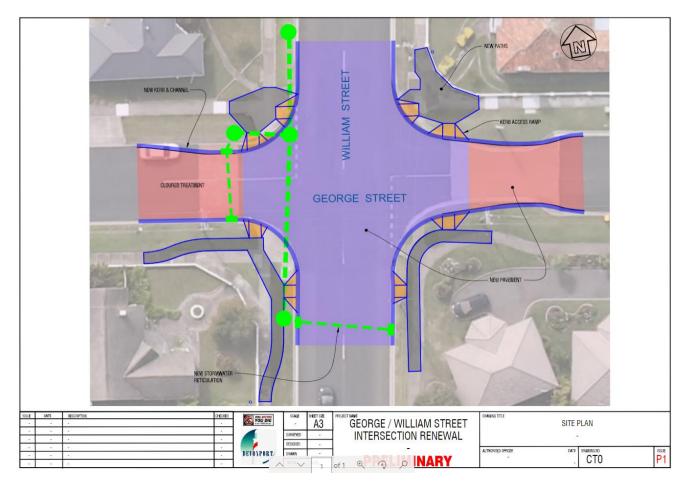
**Proposed status:** Construction in 2022-23

Proposed budget: \$460,000

**Proposed objective:** Asset renewal

**Project justification:** The road pavement and kerb assets are in poor condition and require renewal.

**Project scope:** It is proposed to renew the intersection and kerb on each corner of the road and reseal the road. Subsoil drains will be installed where possible and minor drainage improvements may be required. Access ramps will be renewed including threshold treatment.



Project name: Lakeside Road sight distance improvements

**Proposed status:** Construction in 2022-23

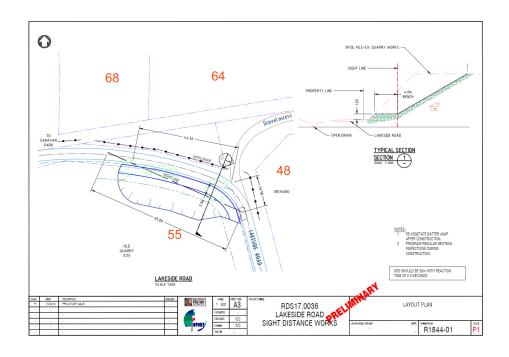
Proposed budget: \$40,000

**Proposed objective:** Asset renewal

**Project justification:** Right turn into an access shared by a residence and a winery has limited sight distance. Historically, Lakeside Road has been low use, but the risk of collision has increased with the growth of the winery and the caravan park.

**Project scope:** It is proposed to improve sight distance around the bend by cutting the batter on the inside of the corner back by up to 4 metres.





Project name: Rural road renewal

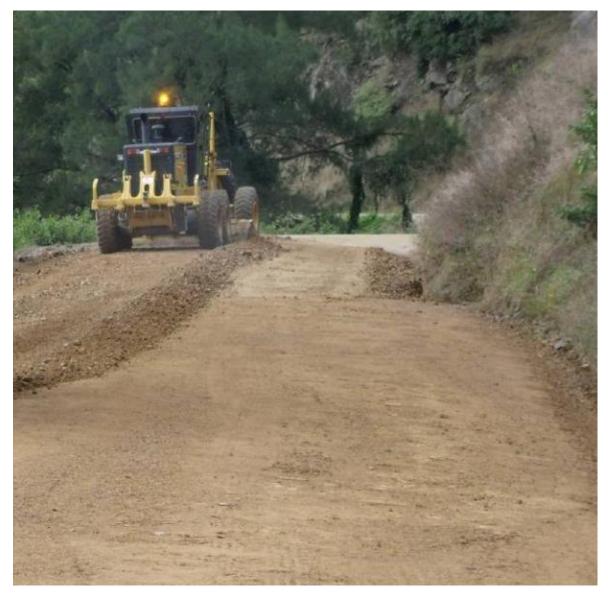
**Proposed status:** Construction in 2022-23

Proposed budget: \$100,000

**Proposed objective:** Asset renewal

**Project justification:** This project represents an annual allocation for rural road re-sheeting and minor corrective actions across the year. This program will be limited to project activities that can be capitalised and is supported by an operational budget allocation for other maintenance activities.

**Project scope:** It is proposed to renew unsealed gravel road by gravel re-sheeting and minor drainage work on a priority basis during the year.



Project name: Tarleton street renewal - Wright street to River road

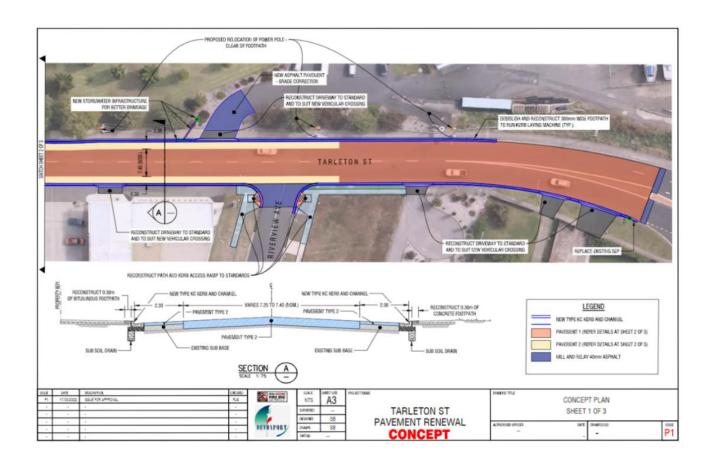
**Proposed status:** Construction in 2022-23

**Proposed budget:** \$1,500,000 (\$506,000 funded by R2R)

**Proposed objective:** Asset renewal

**Project justification:** This section of Tarleton Street is a critical link between the Bass Highway and the East Devonport Port. The road has deteriorated rapidly in the last two years and is approaching end of life. It was anticipated this project would be completed after other road renewal projects in East Devonport, but other projects require details of the Quaylink Project to be confirmed before road design can progress. It is highly unlikely that the requirements of this road (width, lane configuration etc) will change due to the Quaylink Project and so a like-for like renewal is proposed, with pavement design for current and future traffic loading

**Project scope:** It is proposed to renew the pavement kerb and make drainage improvements where possible. Improvements of the streetscape will be considered where they align with the SVEP project



Project name: Coastal Pathway contribution – Don Leith

**Proposed status:** Construction in 2022-23

Proposed budget: \$442,000

**Proposed objective:** Complete the Coastal Pathway in Devonport

**Project justification:** Funding was committed in December 2021 to enable Cradle Coast Authority to execute a contract for the construction of the Don to Leith section of the Coastal Pathway (Min 21/271 refers)

**Project scope:** Contribution to the delivery of the Coastal Pathway project, which is being managed by Cradle Coast Authority on behalf on three councils.

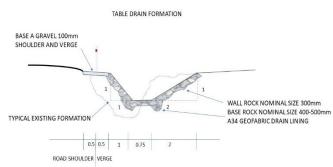

**Project justification:** This allocation is required to renew an existing open drain that has eroded and has the potential to impact road safety.

**Project scope:** Reline the open drain away from the road and stabilise the batter with rock and install geotextile on the bottom.





Project name: Steele stormwater catchment upgrade

**Proposed status:** Construction in 2022-23

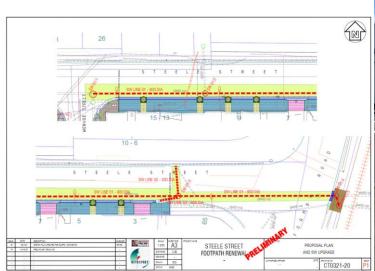
Proposed budget: \$360,000

**Proposed objective:** Asset renewal

**Project justification:** Analysis of the existing stormwater network has identified that the piped system in the catchment is less than required by Council's Stormwater Strategy, resulting in a low to medium risk from flooding to people and property.

Council made an allocation in 2021-22 to renew the footpath on the South side of Steele Street. During the planning for this project, it was identified that the ideal alignment for additional stormwater capacity is under the kerb and footpath, and so making a 2022-23 budget allocation for stormwater upgrades will allow the two projects to be completed concurrently. Increasing the capacity of the stormwater system will reduce the risk from flooding.

**Project scope:** Increase capacity of existing system through the upgrading stormwater lines in Steele Street.





Project name: Cowle Court stormwater upgrade

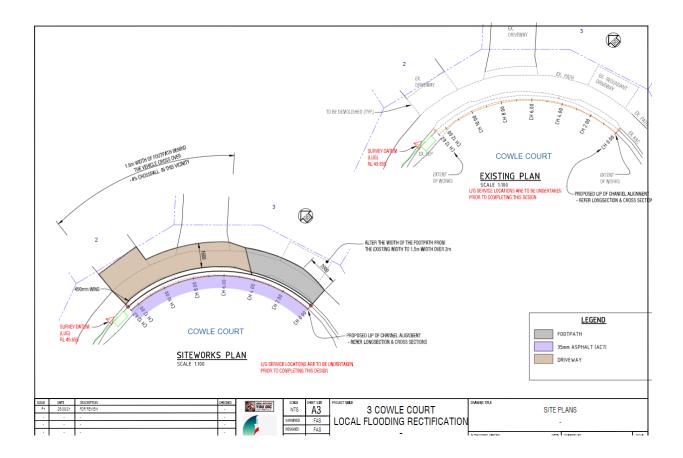
**Proposed status:** Construction in 2022-23

Proposed budget: \$25,000

**Proposed objective:** Asset renewal

**Project justification:** Residential properties in Cowle Court are experiencing overland flow from the road during rain events. An investigation has shown that the improvements to the kerb could reduce the risk.

**Project scope:** Replace a section of kerb and upgrade a stormwater pit.



Project name: Watkinson Street / Don college pipe renewal

**Proposed status:** Construction in 2022-23

Proposed budget: \$100,000

**Proposed objective:** Asset renewal

**Project justification:** The identified pipe has become misaligned and extensively blocked with tree roots.

**Project scope:** Renewal of 85m of the existing line with 450mm pipe. Install stormwater manholes in the existing alignment to facilitate future inspections and maintenance.



Project name: Tasman Street pipe relining

**Proposed status:** Construction in 2022-23

Proposed budget: \$56,000

**Proposed objective:** Asset renewal

**Project justification:** Asset in very poor condition. Reline deteriorated stormwater pipe **Project scope:** Reline entire 44 metres length of pipe D009165.





Project name: College court stormwater upgrades

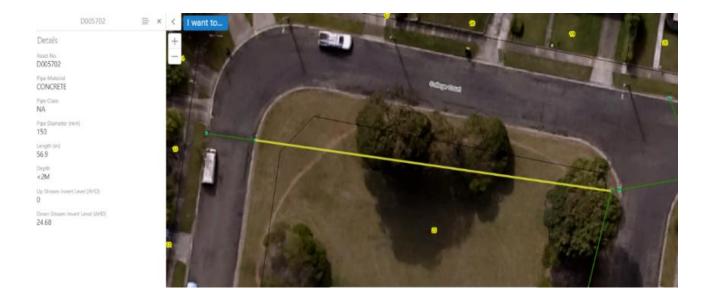
**Proposed status:** Construction in 2022-23

Proposed budget: \$65,000

**Proposed objective:** Asset renewal

**Project justification:** The identified pipe is in very poor condition and under capacity.

**Project scope:** it is proposed to renew the entire length of pipe D005702 with 300mm pipe. A new alignment may be considered to avoid tree roots.



Project name: Devonport Oval stormwater renewal

**Proposed status:** Construction in 2022-23

Proposed budget: \$35,000

**Proposed objective:** Asset renewal

**Project justification:** An investigation has shown the stormwater network to the southeast of the oval is not performing adequately, and requires renewal.

**Project scope:** Install new pit and renew pipe connecting to James Street



Project name: Eugene Street - open drain renewal

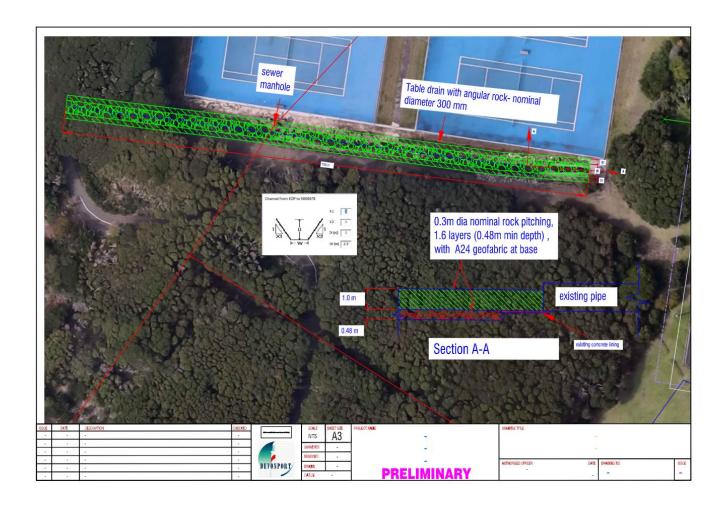
**Proposed status:** Construction in 2022-23

Proposed budget: \$40,000

**Proposed objective:** Asset renewal

**Project justification:** Erosion of the open drain next to Devonport Tennis Club has the potential to damage the fence and courts. The drain cross section is variable, and capacity is limited in some sections

**Project scope:** Widening and rock lining the open drain with larger rocks will ensure the required capacity is available for the full length of the open drain and provides protection for the tennis court infrastructure.



Project name: North Caroline street – new open drain

**Proposed status:** Construction in 2022-23

Proposed budget: \$60,000

**Proposed objective:** Asset renewal

**Project justification:** A lack of drainage infrastructure is resulting in standing water adjacent to the caravan park and has the potential for flooding in severe rain events.

**Project scope:** Construct shallow open drain and connect it to the existing stormwater network in North Caroline Street with a 450 mm diameter pipe



Project name: Macfie Street stormwater renewal

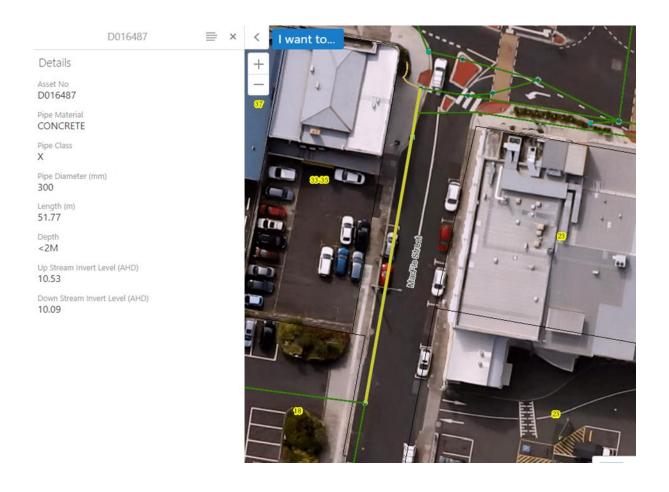

Project name: Highfield Park public toilet

**Proposed status:** Construction in 2022-23

Proposed budget: Not previously listed

**Proposed objective:** \$100,000 (external funding from LRCI Phase 3)

**Project name:** Provide amenities to support use of park facilities

**Project justification:** The implementation of the Highfield Park Master Plan 2018-2028 is progressing, with installation of a BBQ and shelter and the nature play area in 2022-23. A significant learning from other parks is that a public toilet will be required to meet the needs of the community. This is supported by guidelines that measure a recreational facility's value by 'length of stay' which is greatly enhanced by public toilets.

The project is supported by Devonport Community House and has been nominated by Council for external funding under the Australian Government's Local Road and Community Infrastructure Program – Phase 3 (Min 22/36 refers).

**Project scope:** Installation of a public toilet similar to Miandetta Park and Horsehead Creek.



Project name: Aquatic Centre – renew HVAC PAC 2 fan

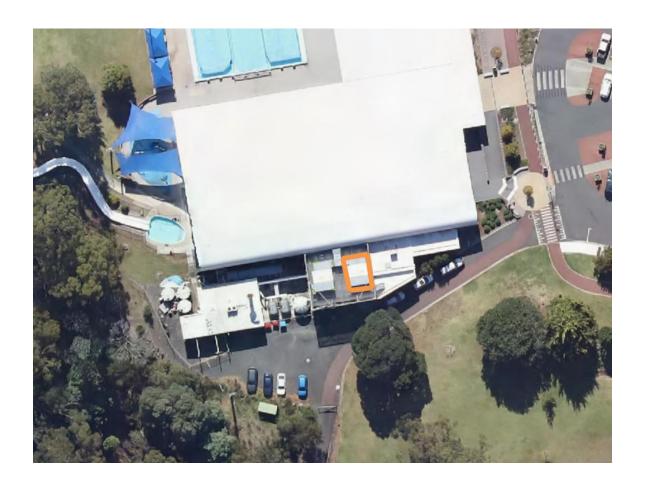

**Project justification:** Devonport Aquatic Centre runs two large HVAC packaged units that maintain the humidity and temperature in the pool hall. In 2021 it was identified that both units were suffering premature failures, and providing poor performance, with the PAC1 unit replaced during the 2021/22 financial year.

**Project scope:** Replacement of the PAC 2 unit at the Aquatic Centre.



Project name: Aquatic Centre lifting equipment renewal

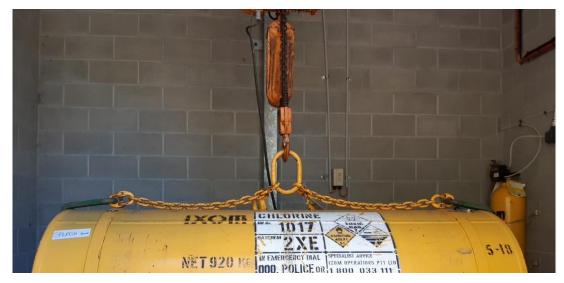
**Proposed status:** Installation in 2022-23

**Project justification:** The existing lifting hoist in the aquatic centre plant room has exceeded its design life, while the geometry of the room means the chains are not able to be used correctly for most loads. **Proposed objective:** Asset renewal

**Project justification:** In 2019, around half the tiles in the 25-metre pool were replaced. Tiles at the deep (west) end were able to remain. In 2021 the west end wall of the 25m pool began failing, so all tiles on that wall were removed to ensure safety of users. It is proposed to replace only the failed areas.

**Project scope:** Replace pool tiles and silicone expansion joints in the impacted area.



Project name: Waste Transfer Station - waste and resource recovery

**Proposed status:** Construction in 2022-23

Proposed budget: \$450,000

**Proposed objective:** Increase resource recovery

**Project justification:** The Waste and Resource Recovery Act 2022 introduces a compulsory waste levy for all waste to landfill of initially \$20/T rising to \$60/T over five years.

Based on projected landfill volumes handled at the Spreyton WTS, Council's exposure to the compulsory waste levy is \$2.1 million over the first five years, if waste services provided by Council remaining unchanged. This cost will have to be borne by ratepayers through the Waste Management Charge and WTS Gate fees. However, initiatives to increase the volume of waste to landfill through reduction and recovery will reduce the exposure to the levy, extend the life of the Dulverton landfill and increase the opportunity for the recycling industry to develop new processes in Tasmania.

**Project scope:** Planning and design work on this project is underway, utilising the 2021-22 budget allocation.

Analysis has shown that the most cost-effective initiative is to improve separation of recoverable waste streams from landfill at the WTS. A project to deliver this may include:

- Reconfiguration of the WTS layout
- Improved recovery facilities (building and plant)
- Variable pricing by waste type
- Charging by mass (requiring weighbridges at key points at the WTS)
- Extensive communication and education programs
- Renewal or improvement to elements of the push pit



Project name: Aquatic Centre – external painting

**Proposed status:** Construction in 2022-23

Proposed budget: \$40,000

**Proposed objective:** Repaint aged surfaces

**Project justification:** The facility exposed outdoor treatments are showing signs of age and requires painting /restraining (outdoor areas have not been re-painted since constructed in 2012).

**Project scope:** Repaint external surfaces.







Project name: Aquatic Centre – pool hall lighting replacement

**Proposed status:** Construction in 2022-23

Proposed budget: \$40,000

**Proposed objective:** Replace internal pool hall lighting

**Project justification:** Fittings in main pool hall and change rooms are at the expected end of life, and failures are occurring. Due to the number of lights and access constraints for replacement works, a bulk replacement as one project is recommended.

**Project scope:** Replace pool and change room lighting with energy efficient LED fittings, with an appropriate IP (dust and moisture sealing) rating to suit the conditions of the pool hall.





Project name: Art Storage Facility –Increased Storage

**Proposed status:** Construction in 2022-23

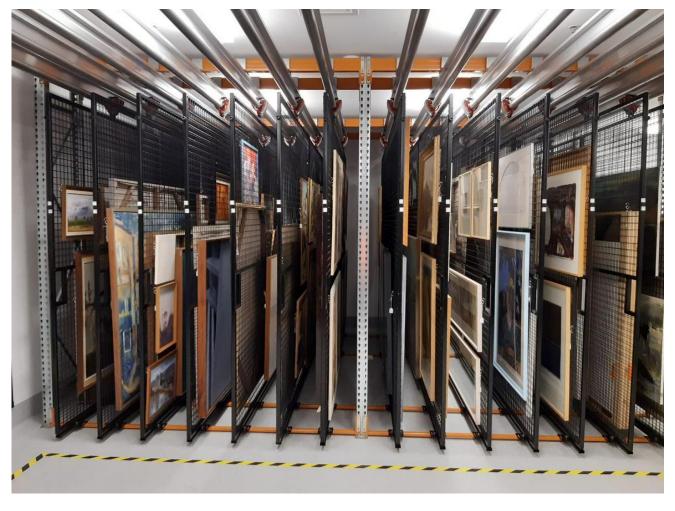
