3.2.3 QUESTION WITHOUT NOTICE FROM THE PUBLIC

RODNEY RUSSELL – 255 STEELE STREET, DEVONPORT

On the 23-7-2018 I asked Council about the missing items belonging to the Devonport Sister Cities Association.

Council's response was that some items had been found.

Q1 Have Council located any more missing items?

Response

The General Manager responded that the items that were missing were some Kimonos. One of those Kimonos has been found, in the relocation from Fenton Way to this building, but the other Kimonos which had been missing since the time of the move from Best Street to Fenton Way have not been located. We have recently met with representatives of the Sister Cities Association to advise them of the situation.

Q2 What does Council intend to do if no more items are located?

Response

The Mayor advised that the General Manager had responded to that by indicating that there had been a meeting with the Executive to explain the situation.

ERIC MOBBS - 5 NIELA CRESCENT, MIANDETTA

Q1 Will Council reconsider its weekday parking policy for the Victoria Parade boat ramp?

The car park is currently vastly underutilised during week days as can be seen by observing at any time of the day. The boat ramp has only been used by a maximum of 6 boats at a time and as for the RVs they are virtually non-existent, except for Tuesday mornings when one of the senior citizens brings his there to conveniently park it. The removal of the 3 hour limit during week days has considerably inconvenienced senior citizens whose club house is directly opposite the said car park. Some now have to walk considerable distances to access the club house. Restoring the conditions previously available would alleviate this problem. Weekend restrictions could still apply.

Response

The Mayor advised that the question would be taken on notice and a response provided in writing.

TREVOR SMITH - 7 GLEN COURT, DEVONPORT

Q1 Is there a special reason, why the Council, didn't decide to place No Standing signs or yellow road markings, at the front of 81 Forbes Street, Devonport, where the Pedestrian Island was built this year? You have placed yellow lines at the front of the Devonport Recreation Centre, where the Pedestrian Island is situated, so as to keep this space clear from vehicles parking!

Q2 After spending hundreds of thousands of dollars upgrading the Visitor Information Centre and the new Art Gallery, to attract tourists and ratepayers to the new Living City complex, why then have you forgot to include signage for opening hours for tourists and local ratepayers? This issue has been prevalent since the complex first opened at the start of this month.

Response

In accordance with Mr Smith's request a response will be provided in writing.

MR DOUGLAS JANNEY - 23 WATKINSON STREET, DEVONPORT

The road over rail crossing in Durkins Road does not meet the "Bump and Rattle standard".

Q1 When are TASRAIL and the Council going to have this crossing up to an acceptable standard?

Response

BOB VELLACOTT – 11 COCKER PLACE, DEVONPORT

Mayor and Aldermen I recently received the following email from a concerned owner of a small business situated in the CBD.

Among other things the following was written:

"Moving Harris Scarfe away has been a massive blow to our Mall. So many retailers/business owners are struggling already and now more concerned and feeling little or no support at the moment.

I know any support even be it small ie promoting our CBD Mall area would be greatly appreciated by all local businesses at the present.

Is there a light at the end of all of this Living City project as it certainly isn't creating any benefit at all to retail at present?

Everything seems to be about the paranaple centre, Waterfront, new hotel and the "new Retail District" which isn't helping existing business. I'm concerned we will see many small businesses closing down if something isn't done to promote our "existing" rather than "new" soon."

Mayor – this is not the first business person who has expressed concern.

Obviously it appears Council's public relations policy may need a review.

Also it appears some are now suffering the consequences of Council provided subsidised premises for new businesses.

Mayor have you or any of the re-elected Aldermen taken the trouble of communicating in person with some of the retailers and traders who would be obviously affected by the Living City project so as you can learn firsthand of their concerns and can you advise me how I should reply to the business person?

Response

The Mayor advised that if Mr Vellacott would like to pass the email on that he had read out she would be happy to contact that person and speak to them directly.

MR TONY BUTLER - 2 DREW STREET, EAST DEVONPORT

On reading the minutes, the question will be, have we got another Alderman? (Mr Butler was referring the incorrect inclusion of a staff member's name as an Alderman in the agenda papers.)

Response

MR MALCOLM GARDAM - 4 BEAUMONT DRIVE, MIANDETTA

- Q1 Noting previous advice from Council that it was funding the fit-out of tenancies in Providore Place from "base build", including certain equipment, to make tenancies fit for purpose, all on the recommendations from Providore Place Devonport Pty Ltd the head lessee, will Council make available the inventory of the Council funded fixtures and fittings supplied to the various tenancies in Providore Place, and a list of those that will remain the property of Council?
- Q2 Will Council please advise if the pavers to the surrounds of the paranaple centre and food pavilion are yet to be cleaned or are they to be allowed to become as grubby looking as those in Stewart Street?

Response

TRISH ALFORD - 12 JAMES STREET, DEVONPORT

May I take this opportunity to congratulate the re-elected and newly elected Aldermen. As part of discussions with the community throughout the election campaign a lot of people commented to me, and there was a considerable degree of press coverage, on the need for greater transparency and accountability.

Q1 If the future stages of Living City and any other matters of a community nature continue to be discussed in Confidential Closed Session, would the Aldermen consider, at the very least, making the voting record – identifying those for and against any confidential motion – to be part of the public record by recording them in the Minutes of the Open Session so the community can see whether decisions made behind closed doors are unanimous or otherwise?

I have been paying particular attention to Council's website trying to keep myself informed. I signed up for the mailing list of electronic information, thinking that would assist me by being alerted without the need for me to continually hunt for information, but was dismayed to find the last item was published in December 2015 so I guess that's not going to help me.

I then noted that Council's website has still not been updated to show the new address for the Devonport Regional Gallery and the Visitor Information Centre – checked again today at 1.25pm. To add insult to injury, a large promotional article on Saturday, 17 November highlighted the Gallery was housed in a converted 19th Century Church – two and a half weeks after it had moved.

Who is the project manager for the first stage of Living City and wouldn't it be their responsibility to coordinate the required promotion of the new co-location, together with ensuring Council's website is updated, taking the opportunity to promote and highlight the new modern facilities and services Council provides to Devonport's residents and visitors?

Response

Q3 What steps will Council take to prevent this happening again?

The General Manager advised it had been agreed with the representatives from the Sister Cities Association that a full inventory will be undertaken, because there are a number of the members of the Sister Cities group that actually have parts of the collection stored at their own houses, in their garages etc. Council also has a number of other items, therefore the plan is to consolidate all of the items and store them together at the Arts Storage facility, catalogued and indexed, so that the same situation will not occur in the future.


