**RESPONSE TO QUESTION WITHOUT NOTICE RAISED MONDAY 28 FEBRUARY 2022**

I write in response to your question without notice, taken on notice at the Council Meeting on Monday, 28 February 2022, as outlined below.

**Q1.** When is the Council going to remove the cycle tracks on Wright Street and at Tasport's expense?

**Response**

The new Bass Strait ferries and changes to freight services will result in increased demand on the East Devonport road network. Council is liaising with TasPorts on determining the scope and timing of upgrades. However, precise timing is yet to be determined.

Provision of improved facilities for cyclists is an identified requirement for the project and part of the detail to be developed as the project progresses.

**RESPONSE TO QUESTIONS WITHOUT NOTICE RAISED MONDAY 28 FEBRUARY 2022**

I write in response to your questions without notice, taken on notice at the Council Meeting on Monday, 28 February 2022, as outlined below.

**Q1.** It has been stated in the Media, at the end of January 2022.

Councils around Tasmania were strongly encouraged by the Premier to ban the use of Jumping Castles and Orb Balls. Wynyard Council has made the decision to ban Jumping Castles and Orb Balls on Council Property. Both Launceston and Glenorchy Councils, which are larger in size than Devonport, have also made the same decision.

Why has the Devonport Council been lagging behind, to make a decision on this issue?

Surely the Ratepayers of Devonport are entitled to know your decision immediately, after this tragedy happened in December 2021?

**Response provided at the meeting**

The General Manager advised that Council have made a decision that if any requests are made for zorb balls or jumping castles on Council land, that Council would not be approving their use, whilst the investigation into Hillcrest is continuing. Council did not make a big deal of this through the media but confirmed that the position of Council is that we would not be allowing those items to be used on council land.

**Q2.** With regard to your reply to my question, from last month's agenda, about the footpath crossover points, at the front of Energy Point at 142 Don Road and at the front of Taxi Combined at 143 Don Road.

Your reply was very non transparent to the Ratepayers of Devonport. Your Engineers are paid at least over \$100,000 a year. Your workforce would have followed the Engineers instructions, to put it where it is.

Why couldn't it have been located at least 10-20 metres further up the road. How many other blunders like this have happened? Can it be moved up further?

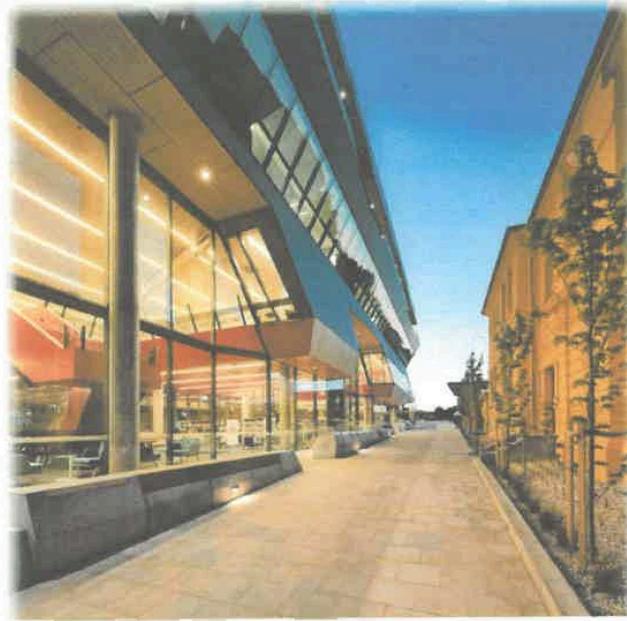
Q3 Please inform -

# Steps in History

STORIES OF PEOPLE WITH SPIRIT  
A PROPOSAL BY RODNEY CROOME & VICKI RUSSELL

### Vision:

Through sharing the life achievements of ordinary people, the extraordinary is possible.

### Executive Summary:

This project aims to build legacy; to tell the stories of NW Tasmanian people with a focus on their resilience in the face of life challenges; to attract attention to inform residents about people from NW Tasmanian communities who have lived extraordinary lives. Plaques with individual names and a brief story for each will be carved in stone as pavers throughout the Paranapple Centre Market Square and be accessible via links for greater detail as an audio app for mobile phones or website links.

## PROJECT COORDINATORS

Dr Vicki M Russell PhD is a Churchill Fellow (2001) who worked for 30 years in non-government sector management in the delivery of trauma counselling; alcohol and other drug prevention; and neurodevelopmental disability (Fetal Alcohol Spectrum Disorder). She trained in narrative practice and has a Certificate of Mastery in the Fetal Alcohol-Neurobehavioural approach (USA). Post graduate research focused on FASD as a policy issue, diverse frames of reference and the contested nature of preferred definitions of problems and solutions. Vicki has developed and delivered education and training programs on trauma and FASD to professional and non-professional groups across all levels of prevention. She is a strong believer in bringing a 'voice' to those who go unnoticed in their contribution to Tasmania.

Rodney Croome AM is an equality activist and holds an honorary doctorate from the University of Tasmania. He was made the inaugural recipient of the Tasmanian Humanitarian of the Year Award and awarded the Chris Carter Memorial Award for contributions to the gay and lesbian community by the Australian Democrats in 1991. In January 2001, Rodney was awarded the Centenary Medal for "service and extensive contribution to gay and lesbian law reform" and in June 2003 he was appointed as a Member of the Order of Australia (AM) for "service to the community as a human rights advocate, particularly through promoting tolerance and understanding of the human rights of gay and lesbian people". Rodney was named Tasmanian Australian of the Year for 2015, and consequently was a finalist for 2015 Australian of the Year.

## TESTIMONY

On September 16<sup>th</sup> 2021, the Governor of Tasmania, the Honourable Barbara Baker stated,<sup>1</sup>

Rodney Croome, found Jessie Spinks Rooke's grave at the Wivenhoe Cemetery, Burnie in a dilapidated state. Vicki Russell and Rodney decided to restore the grave. The City of Burnie Lions Club was approached for financial support and there was unanimous agreement that this project would create a Club lasting legacy in the Burnie community. A local grave restorer was contracted to repair the grave and restore the white marble headstone. Rodney initiated the installation of the memorial plaque. On 16 September 2021, Her Excellency the Honourable Barbara Baker, Governor of Tasmania unveiled and commemorated the life and work of Mrs Jessie Spinks Rooke. In closing her address, the Governor stated, "May I, on behalf of all of us here today, say thank you to Vicki and Rodney for your wonderful commitment and dedication to this project to acknowledge and celebrate the life and work of Jessie Spinks Rooke, a remarkable and outstanding woman."

## PROJECT PROPOSAL

The **Steps in History** Project was conceived during Vicki and Rodney's work on restoring the grave of leading campaigner for Tasmanian women's right to vote, Jessie Spinks Rooke. We realised there is very little acknowledgement of people like Jessie; North West Coasters who overcame substantial challenges to make an important contribution. We witnessed how Jessie's story inspired our fellow NW Coasters to share her achievements and created a sense of pride.

We believe that same effect would be magnified by highlighting other NW Coasters who have made important contributions; that this proposed project will engender a sense of pride in those NW Coasters, especially young people, who would learn about the great achievements their forebears have accomplished. It is a sad fact that some NW Coasters still grow up with a sense they and the place they come from doesn't matter. We want to dispel that myth.

Outside the Paranaple Centre "is Market Square, alfresco market areas with restaurants, eateries and bars. Parking is provided by the multi-storey 500 space car park and everything is a short stroll to the picturesque Mersey River"<sup>2</sup>. Sitting or wandering through Market Square, one can see hundreds of pavers with hardly a pair of feet walking upon them and yet this space is perfect for the inclusion of individual stories on pavers, to attract and inform local visitors and tourists of how NW Tasmania came to be.

This project proposes names and simple words inscribed on pavers will entice visitors to learn more about people. The list of NW Tasmanian people who have contributed to our communities. is extensive. This is an evolving project as more people who are identified can have their names and stories added. Expanded information can be offered using a device that provides information about the names on pavers may be hired or distributed to visitors or downloaded as an app to mobile phones. Links to the Maritime Centre, Councils, Tasmanian Libraries or the range of history pages on social media to learn more would be supported.

The proposal endeavours to equally reflect gender and cultural diversity challenged by the limitations of historical documentation. It is noticeable however that women's contributions are largely hidden from the documentation of early NW Tasmanian history.

As such, the project fits the Mission of Devonport City Council in **Valuing the past, caring for the present, embracing the future** and how the community has been an is "shaped by a rich cultural heritage and enthusiastically embrace present challenges and future opportunities".<sup>3</sup> Further, the project exemplifies the value we place on **Our People** and respectfully working together by recognising each other's talents, skills, experience and knowledge.<sup>4</sup>

## BENEFITS

1. Through sharing the life achievements of ordinary people, the extraordinary is possible. This will add something different to Galleries, Museums and Cultural Attractions<sup>5</sup> and fulfill the Living City goal of “creating a cultural heart for the region” in central Devonport
2. Provide Devonport with a new visitor attraction as the city seeks to increase post-pandemic visitor numbers
3. Engage individuals in proposing possible names for inclusion on pavers
4. Bring residents and school groups into the day to day use of the Paranalpe Market Square
5. Spark more appreciation of, and interest in, the history and culture of the NW Coast.
6. Overcome the challenge of past limitations in our recorded history and bring to life the stories of important people to future generations.

As an indication of what can be achieved, the first 5 profiles of 43 possible people for inclusion are presented as follows:

### 1. DAME ENID LYONS (1897-1981) – teacher, writer, political pioneer, advocate for women

Enid Lyons grew up in Smithton, a stone's throw from the storm-tossed Bass Strait she said was one of her greatest loves, and which she crossed many times to make history. Enid was a trainee teacher when she married Joseph Lyons, who later became the first Tasmanian to be Australian Prime Minister. They raised a family of 12 children at their home in Devonport and at the Lodge in Canberra. Enid was renowned as a public speaker, political campaigner and talented writer. In 1943 she became the first woman elected to the Australian House of Representatives and later the first to serve as a member of Cabinet. In office she helped increase welfare payments for women and children. After leaving politics Enid served as a Commissioner for the ABC and authored several books. Despite her accomplishments, history weighed heavily on Enid's shoulders. She later wrote about entering parliament, *“Every eye would be upon me and for a long time to come the value of women in politics would be judged on what I did. Above all, I must never allow my femininity to become a subject for ridicule.”*

### 2. MAX OLDAKER (1907-1972) – musician, singer, actor, composer

As a child growing up in Devonport, Max Oldaker showed great promise as a pianist and singer. Trained at the Royal Academy of Music in London, Max became a British matinee idol and was an understudy to stars such as Noel Coward and Rex Harrison. Upon returning to Tasmania in 1959, Max was elected to the Australian Composers' Guild and continued his onstage performances. As a gay man, Max faced the challenge of living in a state that was intolerant of homosexuality and criminalised it. But he overcame that challenge to be a respected teacher, performer and broadcaster into his old age.

His obituary said *"few Tasmanians have been more widely known, more universally liked, and generously disposed to give the benefit of experience and judgement to the State which gave them birth."*

### 3. MARGARET AITKEN (1839-1924) – immigrant, pioneer, nurse, midwife

The 22 year old "milkmaid" Margaret Aitken was among the many young, poor Scottish migrants who sailed to Tasmania in the 1850s looking for a new life on the NW Coast. She and husband Geordie settled in Thirlstane where they built a farmhouse that still stands and where she bore 19 children. In the absence of doctors or hospitals, Margaret was nurse and midwife to the entire district. She always rode a white horse so those waiting anxiously for her arrival could see her coming from a distance. She raised several of the children whose mothers died in childbirth and fathers could not care for them. A year before Margaret died, an Advocate columnist wrote, *"In many cases Mrs Aitken went out into the cold and relentless stormy nights of winter to nurse a fellow human being through dark hours of sickness and trouble. Many is the sad story that can be told by the good old dame concerning her visits to the weary and heavily-laden."*

### 4. MARY TESTON LUIS BELL (1903-1979)<sup>6</sup> – Commander women's air force

Mary was a serious-looking and ambitious girl who was interested in flight. In February 1940, as commandant, Mary established W.A.T.C. headquarters in Melbourne; she instituted branches in other States and pressed for the formation of a women's air force auxiliary. Shortages of male ground-staff eventually led to the establishment of the Women's Auxiliary Australian Air Force in February 1941 and Mary was appointed staff officer (W.A.A.A.F. administration), with the rank of Acting Flight Officer. Considered to be a 'socialite' and to lack managerial experience, she was overlooked for the post of director and resigned from the W.A.A.A.F. on 5 June. She rejoined the service in October 1942, worked in several directorates and resumed civilian life on 11 April 1945.

### 5. LORIS AILEEN RUSSELL (1903-1999)<sup>7</sup> – educator, gender equity activist

Loris Russell was an activist in education, gender and social equality. Born at Barrington and educated in Tasmanian State schools, in 1919, at the age of 16, the Education Department granted her a probationary studentship to teach in a junior position at Devonport State High School. Over a 42 year career, Loris' influence extended beyond the classroom, encouraging women teachers to fulfil their potential by applying for promotion and by seeking equal pay. Loris wrote: "What has been done by women in other parts of the world can be done here... until all teachers, irrespective of sex, are filling... positions which they can best fill, the Education Department will be wasting much talent it can ill afford to waste'.

The operating result for the year to the end of February is favourable with actual revenue being higher than budget by \$958K and actual expenses being lower than budget by \$707K, resulting in an overall favourable variance of \$1.66M. The forecast surplus for the year is \$823K.

#### **Rates & Service Charges - \$61K Favourable**

The favourable variance is due to supplementary notices rates issued and additional income from waste charges. A \$42K forecast adjustment has been made.

#### **Fees and User Charges - \$512K Favourable**

The favourable variances include parking \$123K, Transfer Station \$168K and the sale of goods \$101K (catering, equipment hire, scrap metal). Other favourable variances of note relate to development application fees \$77K and facility hire charges of \$63K.

#### **Grants - Operating - \$43K Favourable**

The favourable variance includes higher than budget quarterly payment of the financial assistance grant of \$54K. This has been offset in part by the timing of recognising other grant income. A forecast adjustment of \$72K for financial assistance grants has been made (\$18K x 4).

#### **Contributions - Operating - \$36K Favourable**

The favourable variance is due to contributions from developers relating to public open space and sponsorship towards New Years Eve fireworks .

#### **Dividend Income - \$115K Favourable**

Favourable variance of \$115K due to higher than budget Dulverton tax equivalent payment received. A forecast adjustment of \$115K has been made.

#### **Interest Income - \$18K Favourable**

Favourable variance is a result of funds on hand that are invested until expended on allocated capital projects.

#### **Other Revenue - \$172K Favourable**

The favourable variance includes a training incentive payment from the federal government of \$42K and an adjustment refund for prior year workers compensation insurance of \$68K which was not budgeted for. MPES recoveries for parking fines are ahead of budget by \$29K. A forecast adjustment of \$108K has been made.

**Employee Benefits - \$91K Unfavourable**

The unfavourable variance in direct wages has been offset in part by lower expenditure on uniforms, training and allowances.

**Materials and Services - \$575K Favourable**

The favourable timing variance includes lower expenditure on contractors \$316K, software licences \$127K and consultants fees \$75K.

**Depreciation - \$163K Favourable**

The favourable timing variance relates to the allowance for capitalisation of work in progress.

**Financial Costs**

Immaterial variance.

**Levies & Taxes - \$7K Unfavourable**

Unfavourable variance due to supplementary rates raised on Council sports buildings at Meercroft Park, however this is offset by rates income recognised. The fire services levy payable to the State Fire Commission has been accrued to align with income raised on behalf of the State Fire Commission shown in Rates and Service Charges.

**Other Expenses - \$136K Favourable variance**

The variance includes lower expenditure on event sponsorship and timing of community grants and partnership payments.

**Internal Charges and Recoveries - \$67K Unfavourable**

The timing variance relates to differences between the estimated and actual labour hours that have been charged to capital projects.

**Balance Sheet**

The balance of Capital Work in Progress at the end of February is \$20.85M, including \$12.46M which relates to the LIVING CITY project.

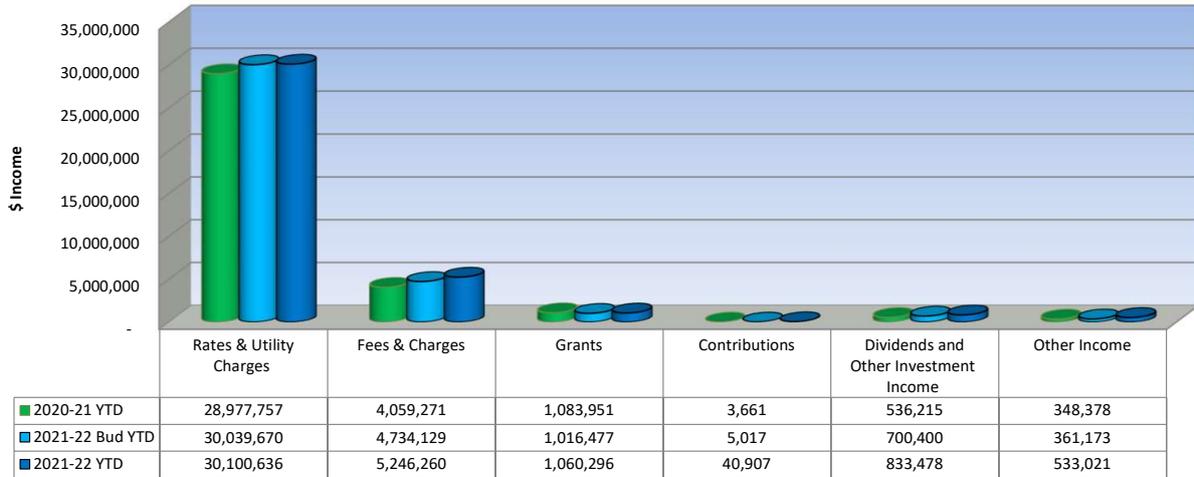

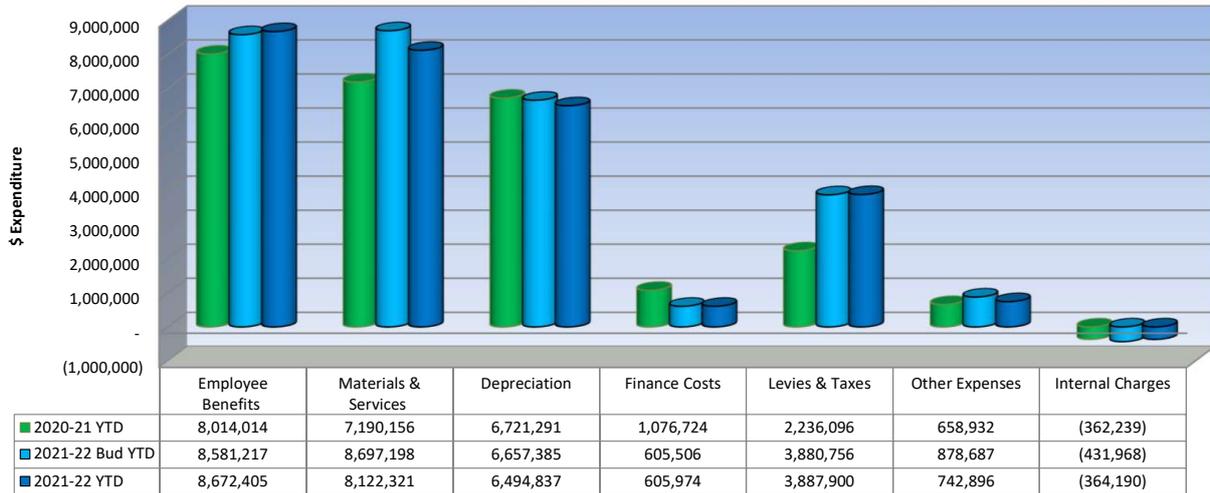
