Devonport Christmas Parade

Guidelines & Entry Form









INFORMATION:

The 2019 Christmas Parade will be held on Friday 6 December and will begin promptly at 6.30pm, departing from the marshalling areas:

Bikes and walking groups: Byard Park (the grassed area near the car park). Enter from Gunn Street or George Street and walk to Marshalling Area.

Large & small vehicles: Byard Park Car Park. Enter from the James Street roundabout.

Participants must present to the registration desk at Byard Park (next to the car park on the grassed area) from 5.30pm to register and collect float number. All entries must be registered and present at the marshalling area by no later than 6.15pm

The Parade may be postponed if inclement weather persists.

The alternate date will be Wednesday 11 December – Registration 6.00pm, Parade 6.30pm

Each individual participant under 18 must have a parent or guardian sign the Indemnity Form.

It is the responsibility of the float organiser to ensure each participant has completed the Indemnity before the parade commences.

GENERAL REOUIREMENTS:

- All entrants must relate to, or be in-keeping with the Christmas Festive Season and/or Community Celebration.
- The organiser retains the right to modify any aspect of the entrant's float/presentation, and the right to position entrants in the Parade where it sees fit, giving consideration to content, theme and impact on other participants.
- Bike riding, skateboarding, rollerblading and scooter riding are all permitted in the Parade, however, appropriate personal protective equipment must be worn at all times. Helmets are a requirement of participation. Persons under the age of 18 should have appropriate adult supervision/permission. Motorbikes are not allowed to participate in the parade unless prior approval has been sought from the organiser.
- Participation by any sort of animal must receive prior approval from the organiser.
- The movement of the Parade will be controlled by the State Emergency Service (SES) and Tasmania Police. Participants must adhere to their directions at all times. Failure to do so will result in the removal of entrants from the Parade.
- Throwing of any item from a float is prohibited, as it may encourage young people to run out in front of moving vehicles. This includes the discharge of water from water pistols.
- · Handing out of items along the Parade route is permitted, if conducted in a controlled manner at street level.
- All electrical appliances should be 'tagged and tested' to comply with Australian Standards and be water resistant.
- Items and props should not pose a threat to participants or spectators.
- If people are aboard vehicles, please make sure they receive adequate adult supervision and reasonable restraining measures are in place, i.e. a rope barrier, or fall perimeter. All passengers in vehicles must wear seat belts or appropriate restraints.







- By entering in the Parade you agree to the Devonport City Council taking photographs and video footage of your entry, including individuals involved. You further acknowledge that Council has the authority to publish and use this material for subsequent advertising and marketing purposes.
- The Devonport City Council prefers entrants to be covered by their own Public Liability Insurance on the day of the Parade. It is acceptable if groups or individuals do not have Public Liability Insurance, however they are required to inform organisers when submitting their application form.
- Please consider whether your entry requires the use of a vehicle. Remember that amazing displays can be achieved with walking groups, allowing participants greater interaction with the crowd.
- Vehicle size is limited, vehicles must be less than 7.4 metres long.
- Only ONE SANTA CLAUS is permitted to participate in the Christmas Parade, this Santa will be provided by the organisers.

VEHICLE SAFETY:

All drivers must adhere to Tasmanian Road Safety Rules and Standards.

The Parade route is mapped on page 3. It will start and finish at the Oldaker/Rooke Street roundabout. Vehicles will be directed back to their marshalling area for unloading. All vehicles MUST unload their passengers before exiting the marshalling area.

- Tasmanian road rules and requirements apply to this event.
- Vehicles and trailers used in the Parade must be registered and driven by individuals with the appropriate license.
- Vehicle registration number, the name of the driver and the driver's licence number must all be provided prior to the Parade (see attached form).
- Vehicles and trailers used in the Parade must be insured (minimum third party insurance).
- Consider the safety of yourself and others, including where you position participants on vehicles. If people are aboard vehicles, please make sure they receive adequate adult supervision and reasonable restraining measures are in place, i.e. a rope barrier, or fall perimeter.
- Do not attach anything to the exhaust, drive/tail shaft or wheels of your vehicle.
- Do not obstruct the steering of the vehicle.
- Do not obstruct brake or reverse lights of the vehicle.
- Do not obscure the driver's vision, including the windscreen and rear view mirrors.
- Secure all large, loose items to the vehicle appropriately.
- The vehicle should not leak any fluids.
- All vehicles must move no faster than walking pace.

All entries will be examined during the marshalling period. Failure to comply with the considerations above could result in the entry being excluded from the Parade.

Please ensure float participants are aware of marshalling details and have completed an indemnity form.





MARSHALLING AREA

A. Bikes and walking groups:

Byard Park (the grassed area near the carpark). Enter from Gunn Street or George Street and walk to Marshalling Area.

B. Large & small vehicles:


Byard Park Car Park. Enter from the James Street roundabout.

Dropping off and picking up children

Please park nearby the marshalling area, Gunn Street or George Street are the closest, and walk your child to the marshalling area to meet your float organiser by 6:15pm.

To collect your child please meet your float organiser back in the Byard Park Car Park. Access to vehicles around the Marshalling Area will be restricted from 5pm until 8pm. Participating children should be walked to their designated meeting place.
